

WBRZ's Father's Day Giveaway Official Contest Rules

1. To Enter: Watch WBRZ-TV, beginning Friday, May 31, 2019, through Friday, June 13, 2019, for WBRZ's Father's Day Giveaway ads the go to WBRZ.com to enter and for contest information. Viewers can enter starting Friday, May 31, 2019, by submitting their name, a video telling a "Dad Joke" or picture of your father and written "Dad Joke", address, phone number, and email address at WBRZ.com and the WBRZ.com App. Registration ends at Noon on Thursday, June 13, 2019.
