

# WBRZ's Father's Day Giveaway

## Official Contest Rules

Visit WBRZ.com to enter The Father's Day Giveaway for the chance to win one of five prizes. Viewers can enter the giveaway starting Monday, June 4, 2018 – June 14, 2018 by submitting a brief essay stating why someone they know deserves the best Father's Day yet in 200 words or less, along with a picture of the nominated father, as well as filling out a basic entry form at WBRZ.com.
