1. Aaron, Arnett (BRPD)- Domestic abuse battery arrest 12/2015. He has since resigned from the department. Prosecution declined in July 2017.
2. Alex, Tenoa (EBRSO)- Filed an Affidavit of probable cause in 2015 in a simple burglary case. It was determined it was untruthful. Case wasn't prosecuted regarding the affidavit he wrote. No longer with EBRSO.
3. Bennett, Brad (BRPD)- Disciplined for conduct unbecoming after getting caught having sex on duty... March 2016. Suspended 87 days.
4. Bolden, Isaac (BRPD)- One of the three officers acquitted after being indicted then arrested for abuse of office. This centers around a trial involving oral sex in a BREC park.
5. Burns, Derek (BRPD)- Arrested for falsifying documents. Case was dismissed due to evidentiary issues in March of 2017. Recently, his termination was upheld.
6. Collins, Chad (EBRSO)- Incident back in May of 2014 where there was untruthfulness as to whether he was wearing his office issued ballistic vest at the time of a shooting. It developed during a narcotics investigation. He was disciplined for untruthfulness.
7. Collins, Logan (BRPD)- DWI arrest February 2017. Attended pretrial diversion.
8. Cosey, Melvin (BRPD)- Cases still pending. He was formally charged with forgery (March 16), false impersonation (Feb 17) and domestic abuse battery (2015).
9. Daniels, Kristopher (EBRSO)- Involved with the incident concerning the ballistic vest with Chad Collins. He was disciplined as well for not disclosing that he was not wearing a vest.
10. Derouselle, Taylor (BRPD)- Simple battery case. Formally charged in January 2014... In January 2017 it was dismissed and paid restitution.
11. Dunn, Evelyn (BRPD)- Retired from BRPD. 2017... Issue involving a shot spotter report. She claimed she responded but didn't respond.
12. Dupuy, Blaine (BRPD)- He was suspended May 2017 concerning a racially charged image that he sent to a group of colleagues.
13. Eddleman, Charles (BRPD)- Livingston Parish Bar Fight knocked a man unconscious.  
2004 DWI arrest.  
January 2016 Livingston Parish bar fight arrested for aggravated second degree battery.  
Plead no contest to aggravated battery 6/26/17 and received three years suspended, three years on probation.  
Restitution hearing scheduled for 4/23/18
14. Edwards, Michael (BRPD)- Suspended for 80 days after an allegation was made that he had sex with a female on duty for conduct unbecoming.
15. Guerra, Christopher (BRPD)- Arrested in 2016 for access device fraud. He used his fuel track credit card for personal gain. After resigning, he used his fuel card and was prosecuted and paid restitution. The matter was dismissed.
16. Hallmark, Donnie (BRPD)- Untruthful about causing damage to his police car after he backed into a light pole at the end of his driveway. Was disciplined November of 2017.
17. Howard, Harry (EBRSO)- Case went through diversion on a simple battery in April 2016.
18. Jackson, Emerson (BRPD) - Third officer in BREC Park sexual act acquitted.

19. Jefferson, Brian (LSP)- Suspension in October 2008 for conduct unbecoming. Inappropriate verbal exchange got into it with someone during a traffic stop.  
August 2008...Reprimand for making an arrest and mislocated the arrestee's personal property.  
April 2015...Made a false statement about the release of a vehicle pursuant to a DWI arrest.
20. Kirst, Jeremy (BRPD)- DWI arrest in 2016 and a simple battery. Completed pretrial diversion.
21. Lake, Howie (BRPD)- Involved in Alton Sterling shooting. Case remains under investigation.
22. Morris, Rodney (EBRSO)- No longer with EBRSO... Arrested 2016 for a sexual assault in the Livingston Parish DA's office jurisdiction. No billed in January 2018.
23. Neyland, Jared (BRPD)- Arrest in Livingston Parish for domestic abuse battery May 2017. Matter dismissed 1/23/18 after completing a domestic violence intervention program.
24. Palmer, Willie (LSP)- Advised he was at a crash scene in when he was not. He was actually at home and suspended for 320 hours. November 2016.
25. Patterson, Michelle (BRPD)- Arrested October 2017 for falsifying records in a marijuana investigation. Awaiting a disciplinary hearing.
26. Pirie, Alec (BRPD)- Internal investigation in late 2014 as to why his police car was found neglected and damaged in Livingston Parish. Damage to windows. He was placed on leave as a result. Violation of department procedures. Resigned.
27. Procell, Adam (BAKER PD) - Baker Police officer terminated. This involved gunshots at the Walmart on Plank Road in Baker concerning Sheriff Sid Gautreaux's son. Arrested for obstruction of justice and malfeasance in office. No billed his charge November 7, 2017.
28. Robinson, Christopher (BRPD)- 2015-Issued a summons for criminal mischief, unauthorized access to records involving situation at his ex-girlfriend's home. Made a False 911 call. Terminated.
29. Salamoni, Blaine (BRPD)- Involved in Alton Sterling shooting. Case remains under investigation.
30. Schilling, Robert (BRPD)- Issue involving excessive force in 2011. Suspension for 15 days but it was overturned. Hair pulling issue in a ditch.
31. Smith, Gerrica (EBRSO)- Office issued ballistic vest during the narcotics investigation. Resigned.
32. Tanner, Blake (BRPD)- Resigned charges pending in Port Allen.
33. Woodring, Steven (BRPD)- DWI arrest in January of 2014. Completed pretrial diversion.
