We have released the following:

Upon receiving a civil lawsuit alleging excessive force by an unnamed Trooper, LSP began immediately working to identify the details of the incident. A detailed search of body camera video revealed the incident was intentionally mislabeled and Brown was involved as he assisted the Ouachita Parish Sheriff's Office with the arrest of a suspect. As

the investigation continued, Detectives concluded that Brown engaged in excessive and unjustifiable actions and failed to report the use of force to his supervisors. LSP detectives obtained an arrest warrant for Brown and placed him into custody.

Over the last nine months, our agency has carefully evaluated and examined our processes and operational practices, which led to fundamental improvements to our operations, training, and administration. These reforms have led to additional administrative and criminal investigations,
