

WBRZ's Mother's Day Giveaway Official Contest Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THE CONTEST. PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING. WINNER WILL BE RANDOMLY SELECTED BY ALL ELIGIBLE ENTRIES.

1. To Enter: Log on to WBRZ.com WBRZ's Mother's Day Giveaway contest page for contest information. Viewers can enter starting Monday, April 19, 2021, by submitting their name, a brief description of why the nominated mom should win, address, phone number, and email address along with a picture of them with their nominated mother at WBRZ.com and the WBRZ.com App. Registration ends at Noon on Thursday, May 6, 2021.
